5. FIRE-FIGHTING MEASURES

Recommended extinguishing media : alcohol resistant foam, CO₂, powders, water spray. Do not use water jet.
Recommendations : Fire will produce dense black smoke. Exposure to decomposition products may cause a health hazard. Appropriate breathing apparatus may be required.
Cool closed containers exposed to fire with water. Do not allow run-off from fire fighting to enter drains or water courses.

6. ACCIDENTAL RELEASE MEASURES

Avoid breathing vapours. Refer to protective measures listed in sections 7 and 8. Contain and collect spillage with non-combustible absorbent materials, e.g. sand, earth, vermiculite, diatomaceous earth and place in container for disposal according to local regulations (see section 13). Do not allow to enter drains or watercourses.
Clean preferably with a detergent; avoid use of solvents.

7. HANDLING AND STORAGE

Handling:
Keep container tightly closed.
Avoid skin and eye contact. Avoid inhalation of vapour and spray mist.

Always keep in containers of same material as the original one.

Storage:

10. STABILITY AND REACTIVITY

Stable under recommended storage and handling conditions (see section 7). When exposed to high temperatures may produce hazardous decomposition products such as carbon monoxide and dioxide, smoke, oxides of nitrogen.
